SECTION 4: FIRST AID MEASURES

First-aid measures after inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If

breathing is difficult, give oxygen. Get immediate medical advice/attention.

First-aid measures after skin contact: In case of contact, immediately flush skin with plenty of water. Remove

SECTION 5: FIRE FIGHTING MEASURES
